



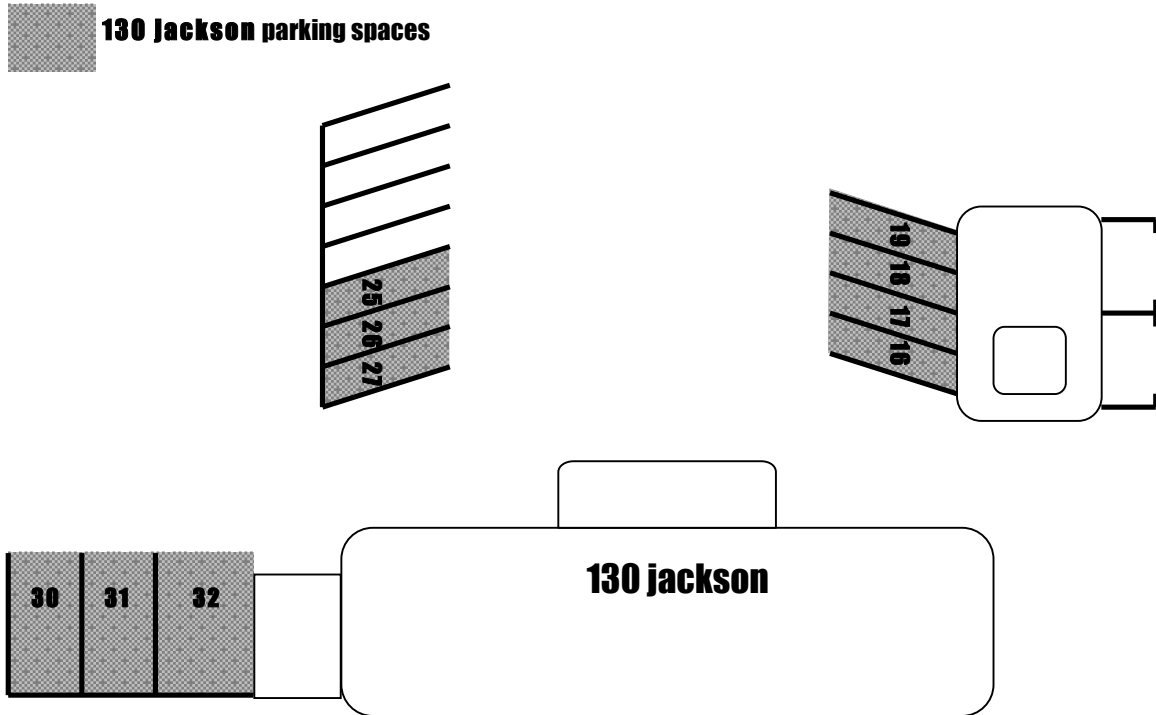

PARKING POLICIES

PARKING

130 Jackson owns and monitors ten (10) parking spaces in the parking lot in front of the venue. Individuals using the venue have access to ONLY these ten spaces without risk of being towed. NLCF typically parks its vehicle and trailer in two (2) of the spaces, leaving eight (8) for individuals in the venue. Below is a diagram of the parking lot and the available parking.



130 Jackson shares this parking lot with neighboring businesses. As such, parking is limited and monitored. Parking in any space not designated as 130 Jackson's is viewed by the neighboring businesses as illegal and they will tow any offender. The owner of the towed vehicle is responsible for all fees associated with parking illegally. 130 Jackson and NLCF are not responsible for any of the fees and cannot provide compensation for vehicles towed.

On any day of the week, if parking is unavailable in the lot in front of the venue, there are a number of recommended areas to park within a 60-second walking distance.

- Monday through Saturday after 5pm, all metered parking is free on Virginia Tech's campus and in town. On Sundays, metered parking is free all day.
- Suggested in-town metered parking includes:
 - Jackson Street
 - Draper Road
 - The Farmer's Market on Draper Road

- College Avenue
 - Street parking is recommended for trailers or buses. Meter costs in town are \$0.25/30 minutes with two (2) hour parking limits (Note: If you park at 4pm, you only have to pay for an hour. But if you park earlier, you must pay the meter until 5pm).
 - Monday through Friday after 5pm, you can legally park on Virginia Tech's campus in the Squires lot and the Architecture Annex lot. You can legally park in both of these lots all day Saturday and Sunday.

If you are towed from the shared parking in front of the venue, the business that tows is Valley Towing located at 810 Jennelle Road Blacksburg, VA 24060. Their phone number is (540) 951-4304. Towing fees are approximately \$250.
